Charity Appeal Drive

Once again we have completed our participation in the Annual Charity Appeal Drive. We were able to sell **\$11,300** worth of tickets through the hand held machine and **\$565** through the online program, for a total of **\$11,865**. This represents a slight increase of sales over last year and has achieved for us a proud 296.6% of our original allotted goal. Our efforts have gained us number **7 ranking out of the 115 participating councils** in overall State sales, including the best Council on Vancouver Island!. Members of our Council were selling tickets in Country Club Centre for only 6 1/2 weeks, six days a week, at about seven hours a day. In addition, they spent many hours before and after weekend Masses and during Hall functions at St.Peter's.
